A. INSTRUCTIONS TO BIDDERS & TERMS AND CONDITIONS:

1. Bids must be unconditional and complete in all respect. Incomplete and conditional bids will be rejected.
2. Bidders must be registered with FBR and must appear on **active tax payer list of FBR**.
3. Bid submitted without Bid Security will be rejected.
4. Tenders/quotations submission Schedule: **January 14th, 2025 up to 3:00 PM.**
5. Quotations Opening Venue/Schedule: Office of the Chief Manager, 1st Floor, SBP Banking Services Corporation, Muzaffarabad.
6. Bid security of Rs. 1,500/- in the shape of Pay Order/ Bank Draft/Demand Draft will have to be deposited along with the bid in favor of SBP BSC Muzaffarabad, which will be refundable to the unsuccessful bidders after scrutiny of the offers and successful bidder after the conclusion of the disposal process. **Bid submitted without Bid Security will be rejected.**
7. The successful bidder will lift and take away the equipment within Fourteen (14) working days from the date of notification of award.
8. Validity of Quotations from the opening date: **90 Days.**
9. Mode of Payment: Successful Bidder shall have to submit 100% of quoted amount within 07 days from the date of notification of award. The Bank will hand over the equipment after realization of proceeds from the bidder.
10. The bidders are strongly encouraged to visit the site to get first-hand information regarding the condition, usefulness, reparability etc. of the equipment before submitting the quotations. The Bank shall bear no responsibility in this regard post-disposal.
11. If the bidders have any queries regarding the equipment, the same shall be communicated to the Bank in writing at least **03 days** prior to the date fixed for submission & opening of the quotations.
12. Quotations shall be opened on the date, time and venue as mentioned above in the presence of bidders or their authorized representatives who may like to be present.
