A bid security of Rs. 10,000/- shall accompany the quotation in the shape of Pay Order/ Bank Draft/Demand Draft in favor of SBP Banking Services Corporation, Gujranwala which will be refundable to the unsuccessful and successful bidders after scrutiny of the offers and conclusion of the bidding process respectively. **Bid submitted without Bid Security will be rejected.**

The highest bidder will have to deposit **100%** of the total offer price in the form of pay orders/Bank draft within Seven (07) days after the issuance of "letter of acceptance" failing which, their bid security may be forfeited and the bank reserves the right to award the work to the Next Highest Bidder.

A. INSTRUCTIONS TO BIDDERS & TERMS AND CONDITIONS:

1. Bids must be unconditional and complete in all respect. Incomplete and conditional bids will be rejected.
2. Bidders must be registered with FBR and must appear on **active tax payer list of FBR**.
3. Bid submitted without Bid Security will be rejected.
4. Tenders/quotations submission Schedule: **September 29, 2025 up to 3:00 PM.**
5. Quotations Opening Venue/Schedule: Office of the Chief Manager, 2nd Floor, SBP Banking Services Corporation, Gujranwala.
6. Bid security of Rs. 10,000/- in the shape of Pay Order/ Bank Draft/Demand Draft will have to be deposited along with the bid in favor of SBP BSC Gujranwala, which will be refundable to the unsuccessful bidders after scrutiny of the offers and successful bidder after the conclusion of the disposal process. **Bid submitted without Bid Security will be rejected.**
7. The successful bidder will lift and take away the equipment within Fourteen (14) working days from the date of notification of award.
8. Validity of Quotations from the opening date: **90 Days.**
9. Mode of Payment: Successful Bidder shall have to submit 100% of quoted amount within 07 days from the date of notification of award. The Bank will hand over the scrap items after realization of proceeds from the bidder.
10. The bidders are strongly encouraged to visit the site to get first-hand information regarding the condition, usefulness, reparability etc. of the items before submitting the quotations. The Bank shall bear no responsibility in this regard post-disposal.
11. If the bidders have any queries regarding the items, the same shall be communicated to the Bank in writing at least **03 days** prior to the date fixed for submission & opening of the quotations.
12. Quotations shall be opened on the date, time and venue as mentioned above in the presence of bidders or their authorized representatives who may like to be present.

13. Bank will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a contract within its jurisdiction if it at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or to obtain the said equipment.
14. No Price Adjustment shall be made for any variation in the market prices, taxes/ duties or change in wages or the Law.
15. The rate quoted will be **"Excluding"** all applicable taxes and tax will be charged over & above the quoted amount.
16. The Bank reserves the right to recover any amount from the payable amounts to the Successful bidder against any losses or damages incurred to the property, data, or persons of the Employer due to the successful bidder or his workers' negligence.
17. The successful bidder shall be responsible for any loss or damage to the Bank property, data, or persons etc. during or due to the operations carried out by the successful bidder under this contract.
