1. This Invitation to Bids follows the Procurement Advertisement (PA) No. *GSD (PROC-III)/ 206515 / Studio Equipment / 2024-25* for the procurement of ***“Supply of Studio Equipment at SBP Studio & Media Centre”***.
2. The SBP Banking Services Corporation has reserved the funds for the procurement planned during the financial year 2024-25. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
3. SBP Banking Services Corporation now invites sealed bids from eligible Suppliers to acquire *Studio Equipment* that meet the following eligibility criteria:
 - a. *Bidder must be an Original Equipment Manufacturer (OEM) or OEM’s Authorized Agent or Supplier of the offered Equipment in Pakistan;*
 - b. *Bidder must have experience of supplying similar equipment to at least 03 (three) verifiable organizations during last 05 (five) years;*
 - c. *Bidder must have Annual Sales volume/Gross Turnover of at least PKR. 20 (twenty) million in any of the last 03 (three) years;*
 - d. *Bidder must be registered with Income and Sales Tax Department and must appear on Active Taxpayer List of FBR;*
 - e. *Bidder must not have been blacklisted or be in breach of performance with SBP or any Organization(s).*
4. The Bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 (PPR-2004) and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
5. All technical bids must be accompanied by a Bid Security in an acceptable form amounting to **PKR. 110,000/-**.

The original bid along with one (01) copy, properly filled in, and enclosed in sealed envelope(s), must be delivered at the office of the undersigned on or before **Monday, February 24, 2025 11:00 AM**.
